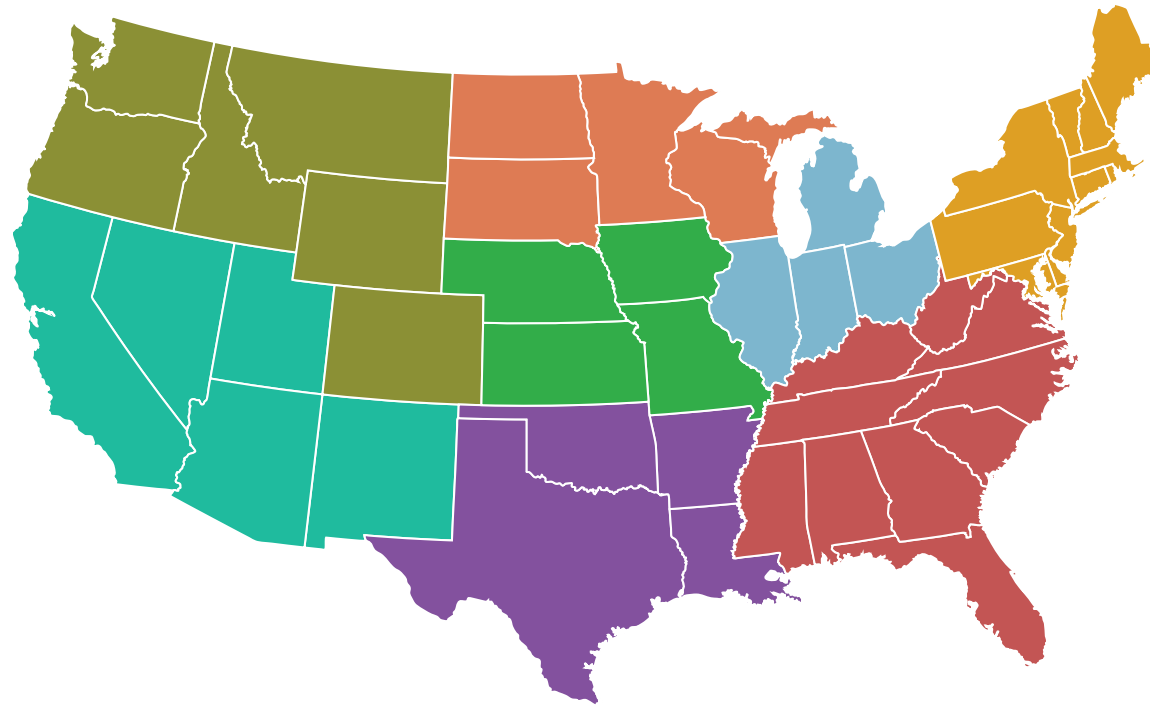
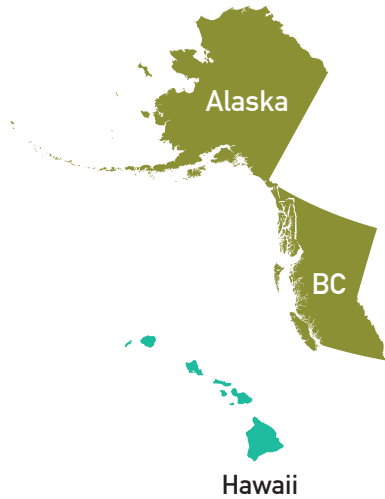


Territory Map
